ASSIGNED GUARDIAN STATEMENT

The following authorization form must be completed by a parent of the applicant if the applicant is **under the age of 18**. The minimum age of an international student at A & L Royal Academy is 14 years old. A completed form and a copy of the Canadian guardian Saskatchewan driver's license or identification card must be on file at A & L Royal Academy Homestay Program before the student is admitted for the term he/she is applying for. (Saskatchewan guardian address must match information below).

In the event of a personal emergency, accident, illness or incarceration, the province of Saskatchewan will require the signature of the guardian before assistance such as hospitalization or legal counsel can be provided. A & L Royal Academy is not permitted to act in place of the parent or guardian. A & L Royal Academy Homestay Program requires that students who are **under the age of 18** have a guardian over the age of 21 living within the city of Regina. If you are **under the age of 18**, you are **required** to have your parent submit a signed statement informing A & L Royal Academy Homestay Program who will be assigned as your local guardian.
